# VII. LEPC/DISASTER MEETINGS

- A. Bureau and Putnam County had their winter storm table top drill on December 10th. No county emergency manger attended. 30 participants from different disciplines – had good exchange of ideas and information. Bureau in the proses of hiring new emergency manager. Putnam County hired Dr. Airhart was hired as new emergency manager as of February 1st. They will meet quarterly. Perry Memorial Hospital closed OB department, no longer birthing center as of January 1st. 2014.

- **C.** Fulton County met in the middle of January, Snow event how it affected the county. Their 2 reports getting them turned in. AMERN member reported now a dingy faculty. ESDA reported on NEXEL and they are planning a hazmat / rail drill after train bridge collapse.

- F. Knox County nothing new, no meeting from last RHCC report. Saint Mary's reported boiler failure for several hours, evacuation discussed for 46 in bed patients, three on vents, boiler fixed within a few hours.

- G. LaSalle County, nothing new from LEPC meeting. Mendota hospital had an all 4 boiler failure, loss all heat, 15 below temp outside, started to discuss evacuation 15 in bed patients, all 4 boiler was fixed within 3hrs. Local task force meets after two years. Working on Special needs population location for emergency response. voluntary registration / self-reporting Thru county EMA.
- H. Livingston County no report.
- I. Marshall County no report.
- J. McDonough County no report
- K. McLean County two tabletops (chemical release from train derailment) schedule for May 19th. One in Bloomington, one in Normal. Several exercises in 2014 throughout the county related to tabletops. Hospital will test DECON and Surge dates not set yet.
- L. Mercer County Al Loeffelhoz introduced his self as the new Emergency Coordinator for Genesis Health care, Nick Border resigned. Will be working with Chris Webster.
- M. Peoria County Peoria Airport drill to be held on April 12th.
- N. Rock Island Presentation from Incident commander of the Tug boat that went down in the Mississippi, what logistic was needed within the quad city with water base disasters. Nursery affected by an air handler that leaked water, portions was shut down, have had a lot of high censes issues, working on bypass plan, does not cover when we go on stabilize and transfer will share when down. Armory evacuated because of diesel truck exhaust next to air handler, seen 8 transported by EMS, another 6 by private vehicle, 14 total treated at trinity Hospital.
- O. Stark County no report.
- P. Tazewell Mike Baker (Hopedale) reported he is retiring in a few months, introduce David Rossi, and David will assume EM position. Hopedale is planning a code sliver tabletop, shooter will going into hospital, Nursing home, and School. Setting date next month. Tazewell had a command and general staff training hosted by Tazewell EMA. Dawn Cook director of Tazewell EMA did a Hot Wash from tornado response. 75 participants took part. 30–40 command staff that responded from Police, Fire, EMS, RMERT, Ameren, and Air Guard, national weather service, PSAP's and local official. Had a good 3hrs conversation about the management of the operation.

- R. Woodford County meeting monthly, next meeting next Tuesday.
