- **B.** Perry Memorial has a Disaster Mental Health Conference coming up November 6-7, 2014. There was a hand out given during the meeting with this information.

- **D.** UnityPoint Methodist is hosting an active shooter drill on November 15, 2014.
- **E.** OSF St. Mary is hosting an active shooter drill October 21, 2014.
- **F.** On September 20, 2014 Proctor, Methodist, OSF, Caterpillar, AMT, Chillicothe, Peoria County, and the State Police did a drill of a functional exercise of a hazardous materials spill in an industry setting and how they respond and correspond with information shared outside there facilities. It went very well, there was a lot learned. Caterpillar agreed to work with hospitals on scheduling a full scale exercise for the county of Peoria sometime in September 2015.
