 - Continuity of Healthcare

 - There duties will be getting the facility infrastructure, utility, telecommunication & internet services, transport services, nutrition & dietary needs, supply chain management, information technology and health care & administrative personnel.
 - Medical Surge
 - The committee members for this will be Douglas Sampson co-chair, Cindy Napier, Mark Lareau and Tom Stecher.
 - There duties will be planning for medical surge by creating training & exercises, and a fine-tuning plan.
 Respond to medical surge by coordinating beds, medical equipment, supplies, and pharmaceuticals to provide the best possible care under conditions.
