- Α. HHS-ASPR CAT
 - 1. The coalition tool was put online by the secretary. There hasn't been any changes but this tool was due again on January 31, 2019. The assessment tool has been completed.
- В. REGIONAL WORKGROUPS
 - 1. Strategic Plan/Regional Plan
 - a. The revised version was sent to Troy. There wasn't any major changes.
 - b. Troy asked if there may be an easier way to get this information gathered.
 - c. The questions was asked if they should keep the plan or remove it. The discussion was that it may be necessary to have but not for it to be put into the plan. Everyone came to an agreement to remove it from the plan but add it to the website for everyone's resources. They discussed maybe finding different routes. The HCID, Region 2 and Ebola plans will need to go out for review.

2. Healthcare Response Coordination

- a. They met and went over some of the bullet points. The minutes were viewed and they will be sending that information via email
- b. They will be creating a document that would help with collecting and keeping up with everyone's NIMS courses. They are hoping to have a signature page done by next meeting. They are wanting to have everyone sign off if you are in compliant. You can only be in compliant if you have completed all the courses 100, 200, 700 and 800.
- c. The three options will be compliant, working on it or almost done.
- d. The other plan they are working on is for the regional chempak.
- e. They would like to know where the chempaks are located and what the guidelines are. During the next meeting the chempak information will be presented by Al.
- f. They are meeting with EM Solutions to get this rolling and would like to have something scheduled by April. More details to come later.

a. They are currently working on the hospital based draft plan for the region.

4. Medical Surge

- a. They met this morning, worked out a few details, but they're still working on it.
- b. Assistance is needed on the communication side.
