## IX. AROUND THE REGION-INFORAMTION TO SHARE

# A. COVID STATUS REPORT FROM EACH HOSPITAL

- 1. Saint Francis Medical Center reported three covid deaths within 24 hours, thirty positive covid patients in ICU and seventy-seven in none ICU, totaled of 107 in house. There are four PUI's in ICU and six in none ICU, total of ten. Twenty-two covid patients and two PUI's on a ventilator totaled of twenty-four. Numbers are decreasing and as of last week, the morgue is full. The mobile morgue deployed to the hospital. Hospitals are currently cremating and backed up.
- 2. Carle BroMenn reported twenty-four positive covid patients; four are in ICU and two on ventilators. Currently three PUI's with zero in ICU. Numbers dropped but expect bump due to the holiday. The hospital is working on a plan to make a specific area in the hospital just for covid patients.
- 3. Carle Eureka reported three positive covid patients, one PUI and the staffing is doing ok.
- 4. Genesis Aledo reported one positive covid patient. The critical access hospital has been helping with covid patient on somewhere to stay. There are seventy-nine covid patients in the whole system. Numbers are decreasing.
- 5. Genesis Silvis has seventeen positive covid patients. The critical hospital are at a two and three. They are hoping that they are at a cease for a while.
- 6. Graham reported nine positive covid patients, two are on vents and three are high flows. Doing well on supplies and staffing has gotten better.
- 7. Hammond Henry reported one covid patient death within 24 hours. Two positive covid patients in ICU and three in medical surge. Things are looking better.
- 8. Hopedale reported they discharged the last covid patient in the hospital. They are having issues with the assistant living not taking their residents back.
- 9. Illinois Valley Community Hospital reported one covid patient, numbers and testing slowed down. Supplies are good and staffing is the current issue.
- McDonough reported as of yesterday one positive covid patient on a ventilator and seven positive covid patients within the hospital. Numbers are down but some of the staff is out.
- 11. Holy Family reported no positive covid patients or PUI's. They are seeing numbers of people coming in with covid like symptoms. Good on supplies but are having staffing issues.
- 12. Saint Elizabeth reported ten positive covid patients and the ICU is full. There are three covid patients in ICU and one is on a ventilator. There was a covid outbreak a local homeless shelter. Transferring patients back to the nursing homes have been an issue.
- 13. Saint James reported eight positive and one PUI waiting results. There are a few positive covid patients in the ED.

- 14. Currently averaging around 40 new cases the last three days. Eight deaths reported the last three days. Numbers are high but they are maintaining.
- 15. Saint Joseph reported twenty-seven positive covid patient; nineteen are none ICU and eight in ICU. There are four PUI's and three are not in ICU and one in ICU. Seven covid patients are on ventilators. One covid death in the last 24 hours and they are utilizing skill-nursing unit. The Orthopedic nursing staff is also assisting.
- 16. Saint Luke reported three positive covid patients that are not in ICU. Two PUI's with no deaths.
- 17. Saint Mary reported eleven positive covid patients not in ICU and one PUI. Two of the positive covid patients are on ventilators. There has been no death. PAPRS needed, they will order.
- 18. Saint Paul reported two positive covid patients and one PUI. Currently two nurses out due to covid. The clinical resource team and mandatory call shifts has been helpful. Received their first behavioral health covid patient.
- 19. Perry Memorial reported no current positive covid patients. The ER not currently heavy occupied but are having staff issues with exposures. They are out of PAPR hoods; Deb will get that information to Randy.
- 20. St Margaret has five positive covid patients on the medical floor. Hospital was at a 70-75% and now is down to 33% of patients. One positive covid patient in the ICU and staffing has been an issue.
- 21. UnityPoint Methodist reported that as a system there are sixty-four positive covid patients. Six covid patients at Pekin, seven are at Proctor and the rest are at the Methodist facility. Twenty-nine are in ICU and thirteen on ventilators. They are good on PPE equipment, and are able to do temperature testing in house with the thermal vision machine. There are between 750 and 1,000 samples given a day. Staffing is also an issue but they are managing it.
- 22. UnityPoint Trinity reported sixty-seven positive covid patients on the Illinois side. Iowa is sitting at twenty positive covid patients. There is twenty-two patients in the ICU. The ICU been in surge the last three weeks. They expanded the ICU for phase one and phase two surge. Twenty-one of the patients are on ventilators. The electives reduced several weeks back due to not having enough room. The numbers are going down.
- 23. Adam Sowells reported some information about Region 5 numbers. Twenty hospitals totaled in the region. There were two hundreds and seventeen positive covid patients' hospitals wide. Twenty-four of them are new positive covid admits. Sixty-one are in ICU, thirty-seven are on ventilators and there were five deaths. They are running into bed challenge.
- 24. Randy informed that there are still six ventilators available for request.

- A. Randy gave the breakdown of the distribution of the vaccine. These are only Estimated numbers. Illinois would receive 110,000 total. Out of that total Chicago would receive 24, 000 and 86,000 will ship to the rest of the State of Illinois. The plan is to have the vaccine by December 15, 2020.
- **B.** IDPH will determine the allocations for each counties local Health Department. Once IDPH determine who receives the initial allocation, it is up to the local Health Department to determine the allocation for each agency in their jurisdiction.
- **C.** OSF Disaster Preparedness Office will be the HUB for the vaccine.
