The kids of OSF Children's Hospital thank you for choosing us as your event beneficiary. You might be just at the beginning of your event planning process or you might be toward the end. Either way, here are a few steps to follow for a successful event.

- Decide what type of fundraising event you'd like to do and pick an area of need within the hospital to support. This needs to be done before your event starts so that your participants know what their donations will be supporting. *See page 3 for a list of funds to choose from.
- Register your event with OSF HealthCare Foundation. Let us know you're planning a fundraising event by submitting the "Let's Start a Fundraiser" form on our website. This puts you in touch with our third-party specialist who can work with you one on one to answer any questions you have.
- Set your fundraising goal. Each fundraising event is different and comes with different levels of support from our OSF HealthCare Foundation staff. *See page 4 for a full list of benefits.
- Keep in mind your timeline, budget and day of execution tasks. As a nonprofit organization, we cannot assist you with your event expenses, but we can supply you with tips and tricks to best manage your event tasks. *See page 4 for the FAQs.



time to celebrate – wrapping up a successful fundraiser



We get it. When you plan an event, everything centers on the actual event. However, it is important to think through and plan what you'll need to do once your event wraps up.

Follow the steps below to ensure all the proper event wrap-up details are completed. Call Jessica DeSantis at (309) 566-5679 to schedule a time for donation drop-offs or to return any borrowed OSF property.

Total up your dollars raised. Any event expenses are the responsibility of the event organizer. OSF is not responsible for any event expenses incurred by your event. Your proceeds minus your expenses is your donation to OSF Children's Hospital.

Submit your total dollars raised. Contributions of cash or checks given during your event should be submitted back to OSF HealthCare Foundation within 14 business days of your event ending.

- Checks can be made payable to: OSF HealthCare Foundation with your event name written in the memo line of the check
- Checks can be mailed to: OSF HealthCare Foundation,

- Cash donations can be dropped off at our Peoria Heights office by appointment only.
- Collect your event collateral. Any signage, donation jars or property of OSF that was borrowed for your event must be returned within seven business days of your event ending.
- Give thanks! Most importantly, thank your donors, your participants and your sponsors! It takes a village to pull off what you did . . . make sure everyone knows just how grateful you are and how much your raised!

Event Planning and Execution Details

- Q: I want to start an event, but I'm not sure where to start. Can OSF help give me ideas on how to jumpstart my planning?
- A: YES! Contact Jessica DeSantis to brainstorm creative fundraising events and tactics. reading through this Miracle Movement Toolkit might help get your creativity started.

Q: Can I use the OSF HealthCare Children's Hospital of Illinois name in my event title?

- A: No. When naming your event, OSF Children's Hospital should not be used in the title but rather listed as the beneficiary. For example, event organizers should not refer to the event as the "OSF Children's Hospital XYZ Fundraising Event." Instead, it should be promoted as "XYZ's Fundraising Event benefiting OSF HealthCare Children's Hospital of Illinois." Event materials should state that 100% of proceeds benefit OSF Children's Hospital. However if your event proceeds are being split between OSF and another organization, it should be clearly stated on all materials.
- Q: Can OSF provide me with event insurance or liability coverage?
- A: No. Since OSF is not hosting the event, we cannot provide insurance or coverage for your event. Obtaining these certificates and any other additional special licenses or permissions is the responsibility of the event organizer and should be part of the initial planning process.
- **Q**: Can OSF guarantee event attendance of patients, physicians and other staff?
- A: No. But we'll do our best to share the word about your upcoming event to encourage community members, staff and patient families to attend. Ultimately, it is up to them on whether they attend your event.
- Q: Can OSF reimburse me for the expenses I incur while planning the event?
- A: No. As a third-party event, any event planning expenses are your responsibility. As a nonprofit organization, OSF HealthCare Foundation cannot legally be responsible or reimburse you for expenses incurred before, during or after your event.

Event Donations and Financials Details

- Q: Can I ask for donations on behalf of OSF Children's Hospital?
- A: If represented correctly, YES! When asking for a donation, do not represent yourself as an employee of OSF Children's Hospital but rather a community member planning an event benefiting OSF Children's Hospital. As long as you state that your event is a community event with proceeds benefiting OSF Children's Hospital, you can ask for donations and sponsorships from friends, family and businesses.



Q: Can OSF HealthCare Foundation provide me with a tax exemption number so I can buy tax-free supplies for my event?

A: No. Because OSF HealthCare Foundation is not hosting the event, you will not be able to use the tax identification number assigned to OSF HealthCare. All federal, state and local taxes are the responsibility of the event organizer during time of purchase.

Q: Can I use OSF Foundation resources similar to how I would use banking resources?

A: No. If you need to use banking services to manage expenses and incoming donations, it might be helpful to open a bank account in your event's name. Contact your legal advisor, tax advisor or bank representative to advise you in this area. If necessary, we can provide a letter stating that the funds raised will benefit OSF HealthCare, a nonprofit organization.

Event Marketing and Promotion Details

Q: Can I receive mailing lists from OSF to invite people to my event?

A: No. Our privacy guidelines strictly prohibit us from sharing any personal data that pertains to donors, vendors, patients and any other known associates of OSF HealthCare.

Q: Can OSF send a press release to the media about my event? Can OSF make sure the media is present at my event for coverage?

A: No. Since your event is a community event and not being hosted by OSF, we cannot inform the media of your event or guarantee their presence at your event. If you wish to contact the media on your own, you are welcome to, but please inform OSF HealthCare Foundation staff of your intentions to do so.

Q: Can OSF create marketing materials for my event or provide any special stationery for me to use?

A: In some circumstances, YES! Refer to the Event Benefits guide for further details. If your event raises a certain amount, we can supply you with limited marketing services such as flyers, save the date cards, invites and other small marketing pieces.

Q: Can I use the OSF Children's Hospital of Illinois logo on my event materials?

A: Depending on your event and if the materials have been approved by us, YES! Before the logo is finalized on any materials including but not limited to flyers, banners, invites, social media posts and other event materials, the logo usage must be approved by OSF HealthCare Foundation staff. Additionally, please refer to the Event Benefits Guide to reference which level of event fundraisers receive this benefit.

Q: Can OSF provide marketing for my event either on your website, on social media or other news/media outlets?

A: In some circumstances, YES! We will include your event details on our OSF HealthCare Foundation website event calendar. Refer to the Event Benefits guide for further details as we may be able to provide additional marketing support.

Q: Can OSF provide me with promotional items with the logo or "swag" items for my event?

A: In some circumstances, YES! If your event raises a certain amount, we can supply you with a swag item of our choosing. Refer to the Event Benefits guide for further details.
