VII. REGIONAL INFORMATION

- 1. PPE Updates
 - a. There was a survey sent, on that survey give your feedback on what items the region will need. The needs are as follow.
 - N95
 - Isolation gowns
 - Earlobe mask
 - Gloves
 - Hand sanitizer
 - Sanitation wipes
 - Goggles
 - Boot covers
 - Face shields
 - b. The members agreed to purchase necessary emergency items with \$70,000 and sit on the remaining balance until April.
 - c. Al Loeffelholz stated that there is also a shortage in needles.

2. Grant Updates

- a. FY21 grant is complete and submitted on time. Currently waiting on the approval from the state to start making purchases. Once the executed grants approved, one major purchase will be a mobile morgue that will be able to hold up to 24 bodies.
- b. The Region 2 exercise went well. Amanda Los from Saint Elizabeth Medical Center stated that the take away they experienced was the pediatric surge policy and needed to test the reunification plan. Also said was they needed proper cameras.
- c. Adam Doellman and Emily McDowell from McDonough Hospital stated that this was the first exercise in their positions and it was very educational. He stated that one of the takeaways is to do better next time.
- d. Randy Haley stated that a takeaway was that the RHCC was not involved right away. He also suggested giving a presentation on what resources are available to the region.
- e. Adam Sowells from UnityPoint Health Trinity stated that the drill went great and the company used did a great job.

II. AROUND THE REGION-INFORMATION TO SHARE

- A. COVID UPDATES
 - 1. McDonough Hospital requesting isolation gowns.
 - Holy Family just got their third COVID related death. Warren County has 341 positive cases with 317 resolved. Those results are from September 13 through last week.

- 3. The Quad Cities has a positive count of 12 as a Genesis Health System. As of yesterday, they now have 23 cases. Silvis campus has three positive cases in the ICU but only have five beds with one spare bed. The concern is that they may not have enough beds available if they get more cases. Iowa has eight positive cases in the ICU and it has been challenging. Transfers are coming from Clinton because the nursing unit has had an outbreak of COVID. They are now short staff on top of being busy. Moline High School and North Scott High School has shut down due to an increase in positive cases.
- 4. Unitypoint Health Trinity has around 20 patient's positive with COVID. The positive cases has increased from last week. Region 5 had around 58 total hospitalized patients, 15 new admissions, 16 positives in ICU and 7 on a ventilator. Region 6 is also seeing a big outbreak.
- 5. OSF Saint Francis Medical Center as of yesterday the total positive COVID patients in hospital is 39. The suspects in hospital is nine and with that, makes 48 total. The accumulative, there are 410 patients and 44 deaths. These numbers are definitely up from where it has been. They will continue to monitor numbers.
- 6. Chris Webster from Genesis Silvis stated that from the EMS side, the helicopter has been transferring patients to destinations that are not typical. The transfers are going to multiple facilities as opposed to the standard destinations.

B. EDUCATION AND TRAINING

- 1. OSF Saint Francis is currently working on a vaccination plan.
- 2. Genesis will have a second large group meeting next week to discuss point of dispensing the closed Pod. They will be working with Rock Island and Scott County on looking at assisting where needed for an open Pod for the community.
- Randy stated that they are looking into doing a tabletop to exercise the Tiered Vaccination plan.
- 4. Tom Stecher stated UnityPoint Health would be hosting a mass dispensing tabletop exercise.
