B. STARCOMM INFO/DRILLS

 - a. The exercise will be the same format as last year and for us to keep it as a qualifying exercise is by moving it into functional. You'll need to staff in at least eight section of hospital incident management team. This is a qualifying exercise for the region.

 - c. Everyone agreed to have the local health departments join us for the drill scheduled in April.

C. EVACUATION EQUIPMENT

These hospitals has volunteered to store the evacuation equipment at their facility and this is what they will be receiving:

St Margaret's - 2 med-sleds with toddler/2 med sleds with infant inserts
And cases, 4 adult med-sleds
OSF Saint Joseph – 2 med-sleds with toddler/2 med-sleds with infant inserts and cases, 4 adult med-sleds
OSF Saint James - 2 med-sleds with toddler/2med-sleds with infant inserts and cases, 4 adult med-sleds
OSF Saint James - 2 med-sleds with toddler/2med-sleds with infant inserts and cases, 4 adult med-sleds
Genesis Illini – 2 med-sleds with toddler/2med-sleds with infant inserts and cases, 4 adult med-sleds
